NEW this year:

• Accredited **Vocational-Technical** school students are now eligible.




• Applicants with a 3.3 GPA or higher must apply for the Academic Excellence category and those below 3.3 (but minimum of 2.0) must apply for the Scholastic Achievement category.

If you have a child/stepchild who is a high school senior or full-time college/vocationaltechnical/graduate student with at least 1 remaining term left to complete and you meet the membership requirements - they are eligible to apply. A few other important things to note:

- Grandchildren are **not** eligible to apply unless the legal ward of the grandparents (documentation required).
- When creating an account in the online application system, it must be in the name of the STUDENT, not the parent.
- If you have previously created an online account, you do not need to create a new one. You can use your existing account to apply again this year, just be sure to check that the email on the account is up to date.

• 2023 membership dues must be paid in full no later than 3/1/23 to be eligible.

Water: Would We Be "Well" Without It?

Have you tested your well water lately to ensure it is safe to drink? In Connecticut, we are incredibly fortunate to have ready access to well water, however, homeowners are responsible for testing it. As stated by the Department of Public Health, "testing is the only way to know your water is safe to drink, and/or if there are nuisance contaminants present for which you may want to treat." And water quality can and does change over time based on a variety of conditions.



If you live in a community that provides municipal services, you really don't have to do much. You can obtain water testing results from your local water company.

When you live in a home served by a private well, one may assume the water is good. But when did you last test it? I suspect that very question is behind a new piece of Connecticut Legislation created to increase awareness of well water testing recommendations and frequency.

Connecticut's Environmental Health and Drinking Water Branch has passed new legislation that details the changes to private well testing laws in Connecticut, known as "EHDW Circular Letter #2022-60" effective October 1, 2022.

The document:

- The law now requires educational materials to be offered on private well testing to prospective buyers and/or tenants by real estate licensees and/or homeowners. This will affect home buyers, sellers, and renters.
- Addresses expanding required testing of newly constructed wells to include Arsenic, Uranium, and Lead, which were not previously State Testing Requirements. This will affect builders and owners of newly constructed private wells.
- Discusses requirements for testing laboratory reporting, which does not directly affect homeowners.

IMPORTANT INFORMATION ON YOUR 2024 CE REQUIREMENTS & DUE DATE

As you know your Continuing Education (CE) is due on even-numbered renewal years and as of this renewal all CE Classes MUST BE COMPLETED 90 DAYS PRIOR TO RENEWING YOUR LICENSE.

- THE CONNECTICUT DCP HAS ONE MANDATORY CE CLASS FOR THIS RENEWAL which is <u>CT REAL ESTATE AGENCY LAW</u>. In addition you will need to take <u>Nine hours</u> of real estate elective courses.
- AS ALWAYS NAR MANDATES ALL REALTORS® MUST TAKE CODE OF ETHICS EVERY 3 YEARS. If you take <u>Code of Ethics it would</u> <u>count as one of your 3 hour elective classes.</u> We are currently in Cycle 7 which runs from 1/1/2022 - 12/31/2024. <u>Login to NAR</u> to check your Code of Ethics Status or give us a call at 203-227-4418 to inquire if you should take Code of Ethics for this CE Cycle.
- Alternatively, licensees may opt to pass the 40-question Connecticut CE Examination during the CE cycle. Contact PSI Examination Services (the testing company) directly: 1-800-733-9267. NOTE: When calling PSI to schedule, be sure to specify that you want the "40 Question" exam in order to renew your CT license.

<u>Salespersons</u>: 12 hours of CE credits must be completed by MARCH 1st, 2024, which is 90 days prior to license expiration date. Salespersons licenses expire annually on May 31st.

Brokers: 12 hours of CE credits must be completed by September 1st, 2024 which is 90 days prior to your new license expiration date of November 30th.

<u>CT REALTORS® Handling Statewide Professional Standards</u> <u>Administration</u>

MFCAR has signed on with the new CT REALTORS® (CTR) Statewide Professional Standards program. You can learn more about timely options for resolving disputes, or how to file an ethics or arbitration complaint by going to <u>http://ctrealtors.com/complaints</u>.
